1. Definition

"Software Product" means the computer program product contained in the Media.

"Licensed Product" means the Software Product which you are licensed by NEC Corporation (hereinafter referred to as "NEC") to use under the applicable NEC Software License Agreement (hereinafter referred to as "License Agreement").

2. License

3. Transference
